SUBJECT: 2009 - 2010 Special Education Teacher Registry

The Special Education Teacher Registry is a training project funded by the Oklahoma State Department of Education, Special Education Services. The training project is coordinated by Chris Francl, Independent Consultant, and the Center for Learning and Leadership/UCEDD at the University of Oklahoma Health Sciences Center. The Special Education Teacher Registry project provides approved training in federal criteria areas for which no special education certification exists in Oklahoma. Those federal criteria areas are Autism, Traumatic Brain Injury (TBI) and Multiple Disabilities/Deaf/blindness (MD/DB). The training includes 32 hours of didactic instruction and a practicum for each area.

The 2009-2010 registration form is included with this correspondence. Please disseminate the form to the special education personnel in your district. The registration form can also be downloaded from our website: <http://www.ouhsc.edu/thecenter>.

Registration for each 32 hour registry training is limited to 60 participants. Limited registration insures that individual attention can be given to participants and accommodates small work groups and a case study format. Due to the limited registration, it is critical that you send this information to staff quickly so that they can register in a timely fashion.

The registration form must be completely filled out, then faxed, emailed, OR mailed by the deadline date in order to be considered. At **12:00 Noon** on the **deadline date**, registrations are finalized using the criteria described in the following priority system. Notifications of confirmation are sent on the afternoon of the deadline date.

Priority #1

Special education teachers who are currently serving a student with the disability being targeted by the registry training. (multiple disabilities/deaf blindness, autism, or traumatic brain injury).

Priority #2

All other special education personnel or general education teachers who are serving a student with the targeted disability. Such personnel may include psychologists,

psychometrists, physical therapists, occupational therapists, speech-language pathologists, social workers, counselors, nurses and paraprofessionals.

Priority #3

Special education teachers who are not currently serving a student with the targeted disability.

Priority #4

All other special education personnel who are not currently serving a student with the targeted disability.

Priority #5

Administrators who are currently serving a student with the targeted disability.

Priority #6

Administrators who are not currently serving a student with the targeted disability.

Priority #7

Independent consultants.

IMPORTANT NOTES

Only personnel holding special education teaching certifications are eligible for placement on the Special Education Teacher Registry. All other participants will receive verification of attendance for the number of hours completed.
